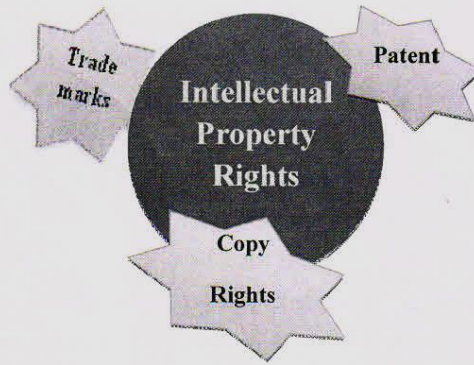

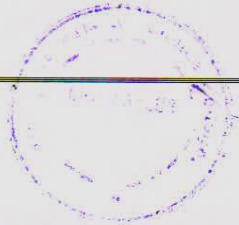

**Introduction :**

Manavlok's College of Social Work, Ambajogai and Vasundhara College Ghatnandur, Tq – Ambajogai, Dist- Beed had jointly organized a National Level Online Webinar on Intellectual Property Rights at 16<sup>th</sup>/Feb/2022. The webinar was successfully conducted with the support and guidance of Dr. Prakash Jadhav, Principal, Manavlok's College of Social Work Ambajogai and Dr. Arun Dalve, Principal, Vasundhara College, Ghatnandur. This webinar was conducted with the aim of promoting research interest among participants and enhance their knowledge about how to protect their intellectual property. Intellectual property is a category of property that includes intangible creations of the human intellect, and primarily encompasses copyrights, patents, and trademarks. It also includes other types of rights, such as trade secrets, publicity rights, moral rights, and rights against unfair competition. Artistic works like music and literature, as well as some discoveries, inventions, words, phrases, symbols, and designs can all be protected as intellectual property. The main purpose of intellectual property law is to encourage the creation of a wide variety of intellectual goods. Intellectual property rights refer to the general term for the assignment of property rights through patents, copyrights and trademarks. These property rights allow the holder to exercise a monopoly on the use of the item for a specified period.

**Objectives:**

- To create awareness about the need and importance of Intellectual Property Rights (IPR) among the faculty and students through this webinar.
- To acquaint the participants with basics of intellectual property rights and to provide an overview of the statutory, procedural, and case law underlining these processes and their interplay with litigation.

**About Webinar :**

Resource Person Dr. Shailesh J. Wadher, Professor School of Pharmacy, Swami Ramanand Tirth Marathwada University Nanded, gave his valuable guidance. This webinar was inaugurated by Principal Dr. Arun Dalve. In the introductory speech Dr. Arun Dalve explained the objectives of the webinar and the importance of IPR in recent world. Total 80 participants including faculties, research Scholars and Students were participated in the webinar. Dr. Shailesh Wadher explained thoroughly about the history of Intellectual Property from beginning to evolving phase. Subsequently explaining the formation of World Intellectual Property Organization and its roles and functions i.e., IPR agreement administration, IPR Practices harmonization etc. Further he explained the Indian scenario of Intellectual property system and the Office of the Controller General of Patents, Designs and Trademarks, Department of Industrial Policy and Promotion. Dr. Shailesh Wadher also explained the role and functions of Intellectual property mechanism in India, the process of filing the Patent application, Copyright application, Trademark application, Design application and the Scheme for Facilitating Start-ups and Intellectual Property Protection. The discussion session had more interactions from students and this workshop kindle the minds of the participants. Dr. Shailesh Wadher explained Major Intellectual Property Rights as follows-

**Copyright** - Copyright is a legal term describing rights given to creators on their literary and artistic works.

**Related Rights** - Rights granted by law to communicators of works to the public Performers Broadcasting Organizations.

**Performer's Rights** - It includes recording, broadcasting and communicating to the public of a live performance. Its duration is about 50 years.

**Rights of Broadcasting Organizations** - It includes Broadcast Reproduction Right. It mainly focuses on Re-broadcasting, Recording and Communicating to the Public of a Broadcast. It has duration of about 25 years.

**Patent** - A patent is an exclusive right granted for an invention, which is a product or a process that provides a new way of doing something, or offers a new technical solution to a problem. The limited monopoly right granted by the state enables an inventor to prohibit another person from manufacturing, using or selling the patented product or from using the patented process, without permission. The time period of patent is about 20 years.

**Industrial Design** - An industrial design is the ornamental or aesthetic aspect of an article which must appeal to the eye. The design may consist of three-dimensional features, such as the shape or surface of an article, or of two-dimensional features, such as patterns, lines or color.

**Trademark** - A trademark is a distinctive sign which identifies certain goods or services as those produced or provided by a specific person or enterprise.

**Geographical Indication** - Geographical Indication is an indication which identifies goods as agricultural goods, natural goods or manufactured goods as originating, or manufactured in the territory of country, or a region or locality in that territory, where a given quality, reputation or other characteristic of such goods is essentially attributable to its geographical origin.

**Layout Design** - It includes layout of transistors and other circuit elements, including lead wires connecting such elements and expressed in any manner in a semiconductor integrated circuit (IC). Trade secret Some inventions, data, information cannot be protected by any of the available means of IPRs. Such information is held confidential as a trade secret.

**Trade secret** - can be an invention, idea, survey method, manufacturing process, experiment results, chemical formula, recipe, financial strategy, client database etc.

**The Protection of Plant Variety and Farmers Right Act, 2001 (PPVFR Act)** - It is an Act of the Parliament of India that was enacted to provide for the establishment of an effective system for protection of plant varieties, the rights of farmers and plant breeders, and to encourage the development and cultivation of new varieties of plants.

In this way Dr. Shailesh Wadher gave thorough information about the intellectual rights and he motivated participants for research and innovation in their respective fields.

It is observed that the participation was very encouraging from various colleges and departments of different Universities in the webinar. There were 80 enthusiastic participants in all including faculties from different colleges and research scholars who participated in the deliberations of the webinar on IPR. Students, research scholars and faculties took active participation in discussion and satisfy queries about IPR.
